**Significant Civil Matters:-**

- **HC/OC 660/2023:** Representing two high-profile individuals in a claim involving defamation and malicious falsehood against a prominent Indian citizen. Parties were previously involved in litigation in the United Kingdom.
- **HC/OC 810/2024:** Successfully defended an application for assessment of a solicitor's bill.

**Significant Criminal Matters:-**

**Significant Arbitration Matters:-**

- Representing former employees of a company being sued for alleged breach of fiduciary duties and in particular, for allegedly accepting kickbacks from the subcontractor. This matter started in the Singapore High Court with a quantum of claim of more than SGD 6 million, and involved four

different parties. The matter is continuing in arbitration proceedings.
